15 **DECLARATION OF ERIC NORDSKOG**
REGARDING DISTRIBUTION OF NET
16 **SETTLEMENT FUND**
17

1 I, Eric Nordskog, hereby declare as follows:

2 1. I am a Client Services Director of A.B. Data, Ltd.’s Class Action Administration
3 Division (“A.B. Data”), whose Corporate Office is located in Milwaukee, Wisconsin. I am fully
4 familiar with the facts contained herein based upon my personal knowledge.

5 2. I submit this Declaration at the request of Lead Counsel to provide the Court and the
6 parties to the above-captioned action with updated information regarding the distribution of the Net
7 Settlement Fund proceeds to the class. I have personal knowledge of the facts set forth herein and, if
8 called as a witness, could and would testify competently thereto.

9 3. I previously submitted a Declaration on August 9, 2023, ECF No. 1965-1, providing
10 the Court with the Post-Distribution Accounting pursuant to the information required by the
11 Northern District of California’s *Procedural Guidance for Class Action Settlements*. See
12 <https://www.cand.uscourts.gov/forms/procedural-guidance-for-class-action-settlements>, at Post-
13 Distribution Accounting, ¶ 1 (requiring specific information about the settlement distribution
14 process be provided in an easy-to-read chart). This chart was also posted on the Settlement Website
15 – <https://www.capacitorsindirectcase.com/> – as required by the *Procedural Guidance for Class*
16 *Action Settlements*. See *id.*, ¶ 1.

17 4. On December 19, 2022, the Court issued an Order Authorizing Disbursement of
18 Settlement Funds (the “Distribution Order”). The Distribution Order approved the distribution of
19 the Net Settlement Funds, less the Court-approved fees and expenses, to the Authorized Claimants
20 on a *pro rata* basis. After payment of Court-approved fees and expenses and setting aside the unpaid
21 portion of the awarded attorneys’ fees together with proportional interest, \$51,459,324.57 remained
22 in the Net Settlement Fund to be distributed to Authorized Claimants.

23 5. On April 14, 2023, A.B. Data sent distribution payments totaling \$51,459,324.57 to
24 Class Members. Payment amounts for the Authorized Claims ranged from \$1.00 to \$7,944,431.76,
25 and the average payment was \$6,161.32. As is typical, Class Members were provided with a 90-
26 day period to deposit their checks before they became void. All payments included A.B. Data’s
27 contact information in the event a Class Member had questions or needed their check reissued due
28 to a name change.
